Table of charges as intended in article 7.4. of the General Terms and Conditions for Port and Quay Dues NV Port of Den Helder

A. Charges port dues

The charges for port dues in euro cents amount to:

1.I. for the entry/mooring of ships in the ports and quaysides of Het Nieuwe Diep:

1. With the exception of the charge for pleasure craft, cruise vessels and inland shipping freighters, payment of the port dues grants the right to the duly specified user for an uninterrupted period of seven days; if this period is exceeded, for each period of seven days or part thereof, all calculated port due charges will be reapplied and the service reissued, unless the overrun is a consequence of the halting of shipping traffic due to the build-up of ice.
For inland shipping freighters the rate is valid for a period of seven consecutive days as well as for an interrupted stay during this period at all quays managed by Port of Den Helder.
For cruise vessels applies a stay of 24 hours. If the vessel exceeds this time limit, the vessel will lapse into the seagoing vessels category.
2. In respect of vessels the mooring of which at one of the quaysides is subject to port dues, if these vessels are subsequently moored at one of the other quaysides within the hereinabove specified period of seven days, in total, the port dues payable for mooring will only be charged once, subject to the highest applicable charge.
3. The charge table for the port dues for ISPS-certified vessels is raised monthly by 24 eurocent per tonne GT (ISPS surcharge).

This charge refers to the payment for the use of facilities provided by the Company or its legal predecessor in the framework of the Port Security Act. The costs for these facilities are exclusively charged to ISPS-certified vessels, moored at ISPS certified quays where ISPS facilities have been installed, because these vessels are required to moor exclusively at quaysides where these facilities are provided.

4. For seagoing vessels with a destination elsewhere and which in connection with this other destination are required by the customs authorities to pass through duly designated channels to the first customs office, and which therefore exclusively make use of the port facilities in fulfilling the required customs formalities, or for crew changes, bunkering and/or resupply, on condition that immediately following arrival the harbourmaster is duly informed, and which do not remain in the port for longer than 8 hours : 23 eurocents per GT tonne.
5. For seagoing vessels referred to in category a. and b. of the Charge Table, which during an uninterrupted period of three months on average moor at one of the quays of Port of Den Helder at least once a week, the port dues calculated will be reduced by 20% following a written request from the counterparty to the harbourmaster and following expiry of the specified period of three months. This reduction is 40% if the use as intended hereinabove on average takes place at least two times per week.
The request for application of the discount must have been submitted within twelve months following expiry of the period for which the discount is applied for.
If it can be demonstrated that over the coming period frequent use will be made of the port facilities, this request can also be submitted in writing in advance.
6. The charge for service-providing vessels, that exclusively sail in the port to provide services to other vessels amounts per quarter to:
23 eurocents per tonne load carrying capacity or per m² occupied water surface x 13 x 2 x 60 %.

B. Charge for quay dues

The charge for quay dues, for keeping objects on the quay space managed by the Company, amounts to:

Quays situated in front of the Koopvaarderschutsluis: 32 eurocent per m² per day or part of a day (with a minimum of € 3,50),

Quays situated behind the Koopvaarderschutsluis: 22 eurocent per m² per day or part of a day (with a minimum of € 2,50),

In the case of sectoring on the quayside, a fixed amount will be charged per sector, irrespective of complete or partial occupation of this sector.

If the goods are removed within 12 hours following initial occupation of the quayside in question, no costs will be charged.

If goods will be stores longer than 1 month, please contact Port of Den Helder

C. Lay up Rate

The lay up rate of € 0.52 / GT (per 7 days) can be applied if the stay of a seagoing vessel in the port lasts longer than one month. For this, a request must be made in advance at Port of Den Helder.

Laying up is only possible if the space in the port allows it. The rate starts on the day that the seagoing vessel moors at the available quay and has been reserved for at least one month or more in advance.

The vessel pays in full for the first month at all times. For stays longer than one month, the rate applies for each subsequent period. Permission must be given by the port authority for any extension.

The quays available for this rate are from number 43 and higher, including quays that are managed by Port of Den Helder behind the "Koopvaarderschut lock". An application can be submitted for quays 33 to 42 where individual appointments are possible.

Shore power facilities will be used at all times.

D. Charges for mooring/unmooring services

1. The charge for the provision of services in the framework of the mooring and unmooring of vessels, depending on the time, for each callout will amount to:

evening (19.00 - 23.00 hours)	€ 168
night (23.00 - 07.00 hours)	€ 168
weekend and national holidays	€ 170
Costs for no-show (if cancelled between 3 hours of the specified arrival time or delays of more than 30 minutes. These costs will not be payable as a consequence of closure of the port in connection with defence activities)	50% of the charge

2. For collection of a vessel within the time period of 1 hour:

Period	Collection charge (in euros)
day (07.00 - 19.00 hours)	€ 131
evening (19.00 - 23.00 hours)	€ 196
night (23.00 - 07.00 hours)	€ 196
Weekend and national holidays	€ 197

3. For the collection of a vessel within a time period of between 1 and 2 hours: a surcharge of 50% on the collection charge as referred to in paragraph 2.
4. For the collection of a vessel within a time period of 2 hours or more: a surcharge of 100% on the collection charge applicable.

Note: 2 people are present on the quay per call. If you would like more people to attend, please contact us.

F. Electricity

The rate per Kwh is 0.2745 and is valid on the following quays: Kooyhaven, Spoorweghaven, Innerharbour, Flaneerkade, Nieuwe Werk, Nieuwe Diep, Visserijkade.

The tariff policy is under evaluation in order to be supportive to the pit stop character of the Port. This implicates that fares could be changed during this applicable period.
